

Precaution a must for prevention: Yogi Nigrani samitis to take up

Coronavirus has only weakened, not finished, says CM

PNS LUCKNOW

Chief Minister Yogi Adityanath said that the coronavirus might have weakened but was not yet finished, hence precaution was the only way to protect ourselves.

The country and the world have been suffering due to global pandemic Corona. There has been extensive damage in many states. We have to keep in mind that the coronavirus has only weakened, not ended. Caution and awareness are the biggest weapons in the fight against it. Carelessness in the disease can be dangerous, so we have to be constantly vigilant," Yogi said while interacting with mediapersons in Gorakhpur on Friday.

Keep following the mantra of maintaining two yards distance from each other. Vaccination is the only shield to protect against corona. There are already two vaccines in the country and some more will be available by next month. Everyone will have to join the campaign of trace, test and treat issued by the government. Under this our monitoring committees are going door to door," the chief minister said and appealed to the people not to run away from sample testing and take the vaccine.

started for those ill-fated children orphaned by the Corona pandemic. He said that the government would take up the responsibility of nurturing and educating those children who lost their parents or earning guardianship due to Corona infection.

"Under the scheme information about arrangement has been made to Mukhyamantri Bal Seva Yojana provide Rs 4,000 per month to

the legal guardian till the child attains the age of 18 years. Along with this, a comprehensive action plan has been prepared for the education of these children through Child Protection Homes, Kasturba Girls Residential Schools and Atal Residential Schools," he

In this sequence, along with a free system of higher and

technical education for children above 18 years, tablets will also be given to them. Besides, Rs 1,01,000 will be provided if the destitute girl was eligible for marriage. The state government is already paying Rs 2000 per month to the children living in Child Protection Homes.

The CM said that 174 children in Gorakhpur region have been identified to be benefited

under Mukhyamantri Bal Seva Yojana, who lost their earning guardians due to Corona. Of these, six children have lost both parents. He met five of these children on Friday morning. Yogi said that officials of the Child Development and Nutrition Department have been directed to provide benefits of the government scheme to the children.

ment has started preparations in this regard, be it cleanliness, sanitisation, fogging or aggressive vaccination," he said.

The chief minister also said that vaccination was going on successfully in the state. Till now, the state has administered more than 2.46 crore doses to people.

"In Ballia, as many as 2.64 lakh people have taken the vaccine with minimum wastage. We are giving vaccine cover to over 4 lakh people in the state on a daily basis. From June 21, the state will start administering around 6 lakhs doses a day while from July, the target is to give at least 10 to 12 lakh doses per day. Vaccination will also take place in the village panchayat ghars,"

The CM also said that the poor would get ration twice in a month for June, July and August, as the state government would also be distributing 5 kg of ration for three months along with PMGKY.

Reiterating the resolve to protect the farmers, the CM said that even during the Covid period, wheat pro-curement from the farmers continued smoothly. "Last year, around 48,000 MT of wheat was procured in Ballia but this time, more than 85,000 MT of wheat has been procured. The state has set a new record of wheat procurement in the ongoing season," he added.

After the Gorakhpur visit on Thursday, Chief Minister Yogi Adityanath reached Ballia where he inspected the District Hospital. The CM inquired about the well-being of patients in the Covid and non-Covid wards. He also took stock of the arrangements at the vaccination centres and Covid care centres.

The CM then visited Haibatpur village in the district where he inspected the distribution of food grains under the Prime Minister Garib Kalyan Yojana.

The cops had arrested two brothers from Myanmar and they were identified as Farooq alias Hasan and Shahid.

 $B^{\text{ickering within the UP unit}}_{\text{of Congress party contin-}}$ ued to hog limelight when a senior leader lodged an FIR perceiving threat to his life from state party chief Ajay Kumar Lallu on Friday.

Senior Congress leader and former secretary Sunil Rai filed a case against Lallu and told mediapersons in Lucknow that he has been receiving several international calls from unknown callers handing out life threats to him and dire consequences if he did not stop opposing Ajay Kumar Lallu.

"These callers have been threatening me not to say a word against Lallu," he alleged.

Rai further said that he had filed an FIR against Lallu six months ago when the latter tore down a hoarding put up by him. "I had put up hoardings around the UPCC office on New Year. The hoardings carried photographs of Priyanka Gandhi, Sonia Gandhi, Rahul Gandhi and some other leaders. Since Lallu's picture was inadvertently left out, the UPCC chief got the hoarding pulled down and trampled upon them," Rai said.

The FIR was lodged at Hussainganj police station Sections 323 (Punishment for voluntarily causing hurt), Section 427 (commit mischief and thereby causes loss or damage to the amount of fifty rupees or upwards) and Section 352 (Punishment for assault or criminal force otherwise than on grave provocation).
"However, the police,

apparently under pressure from Lallu, did not initiate any action against him. I will now take up the matter at all possible levels." he said. Demanding security as Priyanka Gandhi Vadra recentthrown out of the Congress in UP in the recent past.

The Congress leader claimed that if Lallu was not immediately removed, the party would be decimated in the state.

Meanwhile, a media report on Thursday said that UP Congress chief Ajay Kumar Lallu and media chairman Nasimuddin Siddiqui had met Samajwadi party president Akhilesh Yadav in Lucknow recently, giving a new twist to the politics of Congress before the 2022 Assembly polls in the state. However, the Congress leaders contradicted the report and claimed it as false propaganda against them.

13 cos likely to set up data centres in Noida

PNS LUCKNOW

The UP government said 13 1 companies, including domestic and MNCs, have evinced interest in setting up data centres in Noida and were likely to make investments of over Rs 22,000 crore. Among these major com-

panies are Hiranandani group, which has started work on the project with an investment of Rs 6,000 crore and the Adani group, which is setting up two projects of 50 MW each in the district with a combined investment of Rs 4,900 crore. Besides, Indospace Capital Advisors would be investing Rs 1,500 crore and has already applied for land, NTT Global Data Centres, UK, has also been allotted land in Gautam Buddha Nagar (Noida) to set up a 70 MW data centre with an investment of Rs 1,500 crore, STT GDC, Singapore would be setting up an 18 MW project with an investment of Rs 1,100 crore and has

already got the land allotted. Apart from these, the state government has also received intents of investment from companies like Technologies, CTRLS Data Centres, Web Works, RBDC Pte, Singapore, Brookfield Asset Management, Canada, Mantra Data Centres, and

Spain. In a report titled '2020 India Data Centre Market Update', JLL has said that Delhi-NCR region was expected to emerge as a new data centre hotspot as demand from government departments and IT/ITeS were expected to drive further growth.

"As the data centre landscape continues to evolve, the industry is expected to grow exponentially to reach 1,007 MW by 2023 from its existing capacity of 447 MW," the report said, adding that with the growing reliance on digital connectivity, demand was likely to ramp up further due to the imminent rollout of 5G rollout, IoT-linked devices, data localisation and cloud adoption. "India's data centre sector will require an investment of \$3.7 billion over the next three years to fulfil the 6 million sq ft greenfield development opportunity for the industry," it stated.

Savills India also in its latest report titled "Poised for growth: Data centres in India", states that data centre demand in India between 2021 -2025 is expected to touch over 2500 MW with the adoption of 5G, Internet of Things (IoT), Artificial Intelligence (AI), increasing use of cloud services and in smart cities and states that the real estate demand for data centres is set to see an upward momentum by 15-18 million sq ft in the next 4 to 5 years across major Indian cities. At present, the data centres are mostly located in cities like Mumbai, Chennai, NCR, Bengaluru and Hyderabad. MSME and Exports

Promotion Minister Sidharth Nath Singh said that due to the state government's aggressive IT policy, Uttar Pradesh was gradually turning into the country's IT hub. "The government has already spoken to all stakeholders and shared the draft guidelines with them. Formal government orders could not be issued due to the ongoing Covid pandemic. But we are now expediting it and it is likely to be issued soon," he "There is huge interest in

the data centre sector in UP and the response has been beyond our expectation. Many serious and solid players are interested, including Microsoft and Google. The empowered committee would be meeting soon to decide on this. We would issue letters of intent (LoIs) to interested companies soon," an official of the Industry department said.
