

Court to hear today plea to demolish wall beneath 'wazu khana'

PNS LUCKNOW

The Varanasi court, on Wednesday, posted May 19 as the date to hear an application filed by the advocates of the plaintiffs to demolish the wall beneath the wazu khana' of Gyanvapi mosque where 'Shivling' is claimed to have been found during the survey.

The court will also hear on the same day the application filed by the government lawyer to shift the fishes from the sealed wazu khana to safer place.

The lawyers of the plaintiffs in the Gyanvapi-Shringar Gauri case had submitted an application in the court of Civil Judge (Senior Division) Ravi Kumar Diwakar, demanding demolition of the wall beneath the 'wazu khana' in Gyanvapi mosque complex where a 'Shivling' is claimed to have been found during the survey of the Gyanvapi

The government lawyer also filed an application in the same court demanding shifting of the fishes from the sealed wazu khana as their lives were at stake.

Both the applications were to be taken up for hearing on Wednesday but the court proceedings could not begin as the lawyers were on strike. So the court posted the date for the next hearing on May 19.

The civil judge (senior division) had ordered the survey and videography of the Gyanvapi premises.

The lawyers of the plaintiff have claimed that a 'Shivling' was found in the wazu khana of the Gyanvapi mosque during the videography and survey conducted for three days from May 14 to 16 under the leadership of Court Commissioner Ajay Kumar Mishra and two commissioners Vishal Singh and Ajay Pratap Singh in the presence of advocates of both plaintiffs and defendant and representatives of the government, district administration and Shri Kashi Vishwanath Temple. However, the advocates of the defendant claim that it is a fountain and not a

After the claims and counterclaims, the court had ordered the district administration to seal the place where the 'Shivling 'was claimed to be found during the survey.

The court also prohibited the entry of any person in this area. However, the Supreme Court has allowed Muslims to offer namaz and perform religious observance without any

AIMPLB flays secular parties for their silence over Gyanvapi issue

The All India Muslim Personal Law Board (AIMPLB) has slammed the secular political parties for their conspicuous silence on

the Gyanvapi mosque issue. It said the secular political parties had failed to respond as they should have against the false propaganda against the Muslims and their religious places across the country.

The AIMPLB also termed the silence of the Union government on the Places of Worship Act, 1991 as "criminal". It asked the Narendra Modi government to clarify its position on the Places of Worship, 1991 Act.

An emergency online meeting of the working committee of the All India Muslim Personal Law Board was held on Tuesday night to discuss the Gyanvapi mosque and various other mosques and holy places of Muslims in the country.

The AIMPLB said that on the one hand, hate-mongering forces were spreading false propaganda and targeting Muslim holy places with full force and on the other, the Central and state governments, which had a constitutional responsibility to enforce the Constitution and laws, were silent.

"The political parties that call themselves secular and just are also silent on the issue and they are not coming to the fore against this false propaganda the way they should. Their position needs to be clarified. We hope that they will clarify their position and also stand for the protection of the Constitution and the secular character of the country, and a clear and loud voice shall be raised by them," read a statement issued by the AIMPLB.

Tauqeer Raza bid to give new twist to row

Lucknow (PNS): In an apparent bid to give a new twist to the row over the Gyanyapi mosque in Varanasi, Maulana Tauqeer Raza, the head of Ittehad-e-Millat Council, has claimed that a large number of Hindus converted their places of worship to mosques when they embraced Islam and such mosques "should not be touched".

Maulana Tauqeer Raza is a prominent leader of the Sunni Barlevi sect of Islam.

"There are many mosques in the country where there were temples before. Those temples were not razed, just converted into mosques when people adopted Islam. Mosques should not be touched, and if anything is done forcefully, Muslims will oppose the government," Maulana Raza said.

Issuing a threat of violence, Maulana Raza said, "The day Muslim youths become angry, the day I lose control over them, the day these youths take law in their hands, you will have no place to hide." Justifying the plunder and violence during the Mughal rule, Maulana Raza said, "The Mughal rulers did not attack the temples."

Millat Council's Tauqeer Raza Khan is known for making incendiary remarks on religious issues and has issued provocative statements in the past. In January this year, while speaking at a public rally in Bareilly, he had said "I see the anger within my Muslim youths and I am afraid that the day this anger bursts out, the day I lose control over them...I want to warn my Hindu brothers that I'm scared that the day my Muslim youths are forced to take the law into their hands, you will not find a place to hide anywhere in India.

In April this year, while speaking against the demolition of encroachments in Bareilly, Raza had said, "The day Muslims come to the streets, one must understand that they will be uncontrollable. Therefore I warn the government and Prime Minister Narendra Modi in particular of consequences if he fails to correct this way of taking action with immediate effect."

The AIMPLB has constituted a legal committee to look into the 1991 law on places of worship and the decision regarding Babri Masjid and to present the case effectively. The committee members are Yusuf Hatim Muchhala, Mohammed Arshamshad, Fazil Ahmad Ayubi,

Rasool llyas and Kamal Farooqi.

The meeting of the AIMPLB decided that a peaceful people's movement could be started if required. Taking brothers of other minorities into confidence will awaken public opinion on the common responsibility for respecting and protecting religious places of worship and holy places, it said.

The meeting appealed to the preachers and Islamic scholars to

address the issues of importance of the masjid, its place and sanctity in Sharia and protection of the masjid during the Friday sermons in the next three weeks.

"False claims are being made and we should counter these claims scientifically and legally," the AIM-PLB said and appealed to Muslims to be patient, work steadfastly and present their case to the people without provocation.

Maulana Rabey Hasan Nadvi resided over the meeting, AIM-PLB general secretary Khalid Saifullah Rahmani conducted the meeting, Syed Arshad Madani vicepresident of AIMPLB and 45 other members participated in the meeting. The then Congress government at the Centre headed by Prime Minister PV Narasimha Rao had in 1991 brought a law pertaining to the places of worship. The law provides for maintaining the status quo and prohibits conversion or changing the religious character of any place of worship that existed as on August 15, 1947. Anyone attempting to do that can face fine and imprisonment from one year to three years. A bench of Justices DY Chandrachud and PS Narasimha is hearing the Gyanvapi issue. The bench on Tuesday had directed that the area where the shivling was found should be protected. The bench added that no manner of restriction should be imposed on Muslims on entering the mosque to offer namaz or religious observances. The apex court has listed the matter for further hearing on

Farmer makes immolation bid due to police inaction in Budaun was taking his licensed double-

Upset over inaction of the local police in Budaun, a farmer reached the district police chief's office along with his wife and children and later set himself on fire.

The incident took place on Wednesday morning and the victim was rushed to the district hospital from where he was referred to the medical colof his critical condition.

On allegations of the victim, the senior superintendent of police suspended the station house officer and four other guilty cops and ordered a probe to initiate further legal action

against them.

Reports said that Krishnapal, a resident of Rasulpur under Civil Lines police station of Budaun reached the SSP's office along with his wife and children on Wednesday morning. He alleged that his wheat field was set on fire by some local miscreants 20 days back and though he had filed a complaint about this the in-charge of Mandi police outpost did take any action.

For the past few days, the farmer was making rounds of the police station and had also met the local officers pleading for justice but no action was being taken.

The farmer alleged that instead of taking action, the policemen applied pressure on him to take back the complaint and forget the incident.

The farmer's family alleged that the policemen of Mandi outpost connived with the accused and were now threatening them with dire consequences if they pursued the

Upset with the police crop, the only means of livelihood of the family, Krishnapal on Wednesday morning reached the SSP's residence along with his family, sprinkled petrol on himself and set himself on fire. The cops present the accused, Brajveer Singh,

there somehow doused the fire and rushed him to the district hospital where his condition was stated to be critical.

After learning about the entire incident, SSP Budaun suspended five policemen including the local inspector, and ordered a probe. He also issued orders to register a case against those involved in damaging the crop and to take stern legal action against the accused.

Meanwhile a man was arrested for allegedly shooting his elder brother, who tried to stop him from carrying a gun to the field, in Bijnor.

Bijnor's Superintendent of Police Dharamveer Singh said

SP legislators to meet on May 21

Lucknow (PNS): Ahead of the budget session of the UP Vidhan Sabha commencing from May 23, the Samajwadi Party has convened a meeting of party legislators here on May 21.

All MLAs and MLCs of SP have been asked to be present in the meeting. The SP has 111 MLAs and its two allies, Suheldev Bhartiya Samaj Party has six and Rashtriya Lok Dal has eight MLAs. All eyes will be on the participation of Shivpal Singh Yaday, the estranged uncle of Samajwadi Party chief Akhilesh Yadav, in the meeting. He had contested the assembly election on SP ticket and was elected from Jaswantnagar assembly constituency in Etawah district.

As per the provision of the anti-defection law. Shivpal Yadav is an MLA of Samajwadi Party and covered by the party whip in the assembly. He floated his own political party in 2017 and is the president of the Pragatisheel Samajwadi Party (Lohia). Shivpal Yadav felt very offended as he was not invited to the first meeting of the newly elected MLAs of SP held here on March 25. The SP had later clarified that the meeting was of SP MLAs and a meeting of the allies of the party would be held at a later date where Shivpal Yadav would be invited. Shivpal Yadav however has not visited the SP office since his election to assem-

The budget session will be the first session for SP chief Akhilesh Yadav, where he will perform the role of the leader of opposition. Earlier, his father Mulayam Singh Yadav and uncle Shivpal Yadav were also the leader of opposition in UP

For Akhilesh Yadav, it is going to be a tough task of keeping his flock of 111 MLA and 14 MLAs of allies SBSP and RLD together. Samajwadi Party's alliance with the RLD is almost over and only a formal announcement is awaited. Akhilesh Yadav is unhappy with RLD chief Jayant Chaudhary for visiting the family of Mohammad Azam Khan in Rampur. Azam Khan, the Muslim face of SP, is 10-term MLA and is presently lodged in Sitapur district jail for the past 27 months, facing charges in as many as 88 cases.

Relations of Jayant Chaudhary with Akhilesh Yadav are also strained over the reluctance of the SP to send him to the Rajya Sabha. Akhilesh Yadav, ahead of UP assembly elections, had promised Rajya Sabha seat to Jayant Chaudhary. After elections, Akhilesh Yadav is said to have had second thoughts on this issue.

On the basis of its strength in the UP assembly, Samajwadi Party can send three members to Rajya Sabha. One Rajya Sabha candidate will need 37 votes while RLD has only eight MLAs.

3 pilgrims die in road mishap in Mathura; CM expresses grief

At least three pilgrims died and 32 were injured on Mathura-Delhi Yamuna Expressway on Wednesday when their bus rammed into a stationary truck

carrying construction material. Sixty pilgrims were returning from Mathura's Govardhan to the national capital's Shahdara in the

Chief Minister Yogi Adityanath has expressed deep grief over the death of three people in the accident in Naujheel area of Mathura. He directed the local officers to ensure best medical treatment to all those injured in the mishap.

The injured have been admitted to the district hospital and the condition of six of them is stated to be critical.

They were returning to Delhi after paying obeisance to the deity when the accident took place leading to the death of three pilgrims and injuries to about three dozen others. There were devotees in the bus who were returning after darshan of Girirai

The SP said that the front part of the bus was completely damaged by the impact of the collision and the devotees sitting in the front of the bus sustained serious injuries. He said that three devotees died on the spot.

The injured were first taken to the community health centre at Nauiheel from where about two dozen injured were referred to Kailash Hospital in Noida and six to the district hospital.
